The Board of Education of Franklin City Schools held Public Hearing at the Junior High Media Center on Tuesday, May 26, 2015 at 5:45 p.m.

Mrs. Lori Raleigh, President, declared the Public Hearing open at 5:45 p.m.

Mrs. Raleigh said Ohio Revised Code sections 3307.353 and 3309.345 mandate any time a public school district seeks to re-employee a system retiree in the same position that the retiree held prior to retirement, the district must meet two requirements.

- 1. Give public notice 60 days before the re-employment begins that the person is or will be retired and is seeking reemployment with the district. The notice must include the retiree's name and the time, date, and location of the public meeting that is to be held to discuss rehiring the retiree.
- 2. The District must hold a public meeting between 15 and 30 days before the reemployment begins to discuss rehiring the retiree.

Once a school employee retires under the requirements of the State Teachers Retirement System (STRS) or the School Employees Retirement System (SERS), any monthly pension is issued directly by the retirement system.

Ms. Coleman has experience in early childhood development and with our kindergarten program. This knowledge and experience will prove useful, as the district implements All-Day Kindergarten for the 2015-2016 school year.

Upon rehiring Ms. Coleman, the district would save an estimated annual salary amount of \$31,904.

Mrs. Raleigh asked if there were any comments or discussion and left the floor open.

Hearing no request for discussion or comments, Mrs. Raleigh declared the Public Hearing closed at 5:55 p.m.

Also, I think the board has tried very hard to make sure that our teachers are compensated competitively in the county and that continues to be our goal. One

example of this commitment to our teachers is that in the past five years Franklin is only one of three districts in the county that did not freeze salary steps. You are important to us, we appreciate what you do and like I said I'm remaining optimistic that we'll get through this with an agreement that everyone will be happy with.
