Ohio Revised Code sections 3307.353 and 3309.345 mandate any time a public school district seeks to re-employ a system retiree in the same position that the retiree held prior to retirement, the district must meet two requirements.

- 1. Give public notice 60 days before the re-employment begins that the person is or will be retired and is seeking reemployment with the district. The notice must include the retiree's name and the time, date, and location of the public meeting that is to be held to discuss rehiring the retiree.
- 2. The District must hold a public meeting between 15 and 30 days before the reemployment begins to discuss rehiring the retiree.

Once a school employee retires under the requirements of the State Teachers Retirement System (STRS) or the School Employees Retirement System (SERS), any monthly pension is issued directly by the retirement system.

Mrs. Raleigh said the Warren County Career Center Board of Education recently hired a treasurer. The process of finding the right qualified treasurer and assistant is difficult with the limited pool of applicants. I was glad to find out Mrs. Bellamy and Mr. Isaacs were interested in continuing employment with our district. Their experience, knowledge and loyalty to this district are very much appreciated.

NEW BUSINESS

1. <u>EMIS Coordinator</u> – Dr. Sander, Superintendent, said there are currently two positions contracted through the Warren County ESC in which the Franklin City School District receives 100% of the services provided by the employee (EMIS Coordinator and Special Education Supervisor). Generally, the district would utilize services where an ESC employee would work 2 days at Franklin and the other 3 days at another district, which results in shared services of the employee. With the case of the EMIS Coordinator, the employee is assigned 100% to Franklin. Therefore, the district is paying an ESC administrative fee for the services of an employee who works full time at Franklin. Therefore, the district could save some money by bringing employee(s) in house.

Mrs. Bellamy, Treasurer, pointed out the ESC employees pay 15% of their health insurance premiums while Franklin employees pay 20%. So, there are a few differences in an estimated cost savings other than the administrative fee.

Mr. Sizemore asked if Dr. Sander would be making a salary recommendation if employee(s) where brought in-house.

Dr. Sander said the salary recommendation would be comparable.
